 RESOLUTION:- The St. Teresa's Society, Santacruz, Bombay-400054,
 was granted permission to start College of Education with effect
 from academic year 1973-74 on certain terms and conditions. One
 of the condition, amongst others, was that the St. Teresa Society
 which conduct the college of Education would not claim any grant
 from Government for a period of six years for running the said
 College and that it would not claim any rent from Government for
 the Building constructed for the College. The College was
 accordingly managed by the Society out of its own funds without
 any grant-in-aid from Government for the last six years.
- 2. The question of bringing the said College of Education on grant-in-aid basis with effect from 1979-80 was under consideration of Government for some time past. Government is now pleased to direct that the St.Teresa's Institute of Education, Santacruz, Bombay-400 054, should be brought on the list of Government aided Colleges of Education with effect from 1979-80 and that the said College should be held eligible for payment of grants in accordance with the Grant-in-aid rules in force.
- 3. Government is further pleased to authorise the Director of Higher Education, Pune to sanction the payment of an amount of Rs.10,000 (Rs.Ten thousand only) as "on account" grant to the St.Teresa's College of Education, Bombay-400 054 which should be adjusted against the grant finally admissible to this College during the current year in accordance with the grant-in-aid rules in force.
- 4. The expenditure on account of payment of "on account" grant of Rs.10,000-sanctioned in para 2 above should be debited to the budget Head "277-Education-B-Secondary Education(n) Teachers Training(n)(V)Schemes in the Five Year Plan(9) Assistance to Non-Government Colleges of Education-Grant-in-aid (277636)" and should initially be not, from the advance of Rs.10,000/- from the Contingency Fund sanctioned under Government Memorandum, Finance Department No.CMF 1179/112/BUD-6, dated 10th September, 1979. The Director of Education should submit a token supplementary demand for recoupment of advance from the Contingency Fund in due course. The Director of Education should also forward the monthly report of paperess of expenditure from the Contingency Fund advance to the Accountant General, Naharashtra-I, Bombay, the Finance Department and the Education Employment and Vouth Services Department.
